Invitation of Bids for Lot 1 Civil Works of Upper Trishuli 3B Hydroelectric Project (37 MW)

- Trishuli Jal Vidhyut Company Limited has allocated funds towards the cost of construction of Upper Trishuli 3B Hydroelectric Project in Nuwakot and Rasuwa Districts, Bagmati Province and intends to apply part of the funds to cover eligible payments under the Contract for Lot 1 Civil Works of Upper Trishuli 3B Hydroelectric Project (37 MW), Contract Identification No.: TJVCL/NCB/080/81/CIVIL-01. Bidding is open to all eligible bidders as per Section V of the Bidding Documents.
- Trishuli Jal Vidhyut Company Limited invites electronic bids from eligible bidders for the Lot 1
 Civil Works of Upper Trishuli 3B Hydroelectric Project (37 MW) under National Competitive
 Bidding Single Stage Two Envelope Bidding procedures. Only eligible bidders with the
 following key qualifications should participate in this bidding:
 - Minimum Average Annual Construction Turnover of the best 3 years within the last 10 years: NRs. 1,800 Million
 - b) Bidding Capacity should be equal to or more than NRs 1,750 Million
 - Minimum Work experience of similar size and nature: Participation as prime contractor or as a partner in joint venture and successful completion or substantial completion of at least One (1) Contract involving civil construction work of Hydroelectric Project within the last ten (10) years, with a value of at least NRs 1,300 Million.

(The similarity shall be based on civil works of a Hydroelectric project of ≥ 20 MW capacity)

- d) For the above or other contracts executed during the period of last ten (10) years a minimum construction experience in the following key activities:
 - (i) Participation as prime contractor or as a partner in joint venture and successful completion or substantial completion of construction (excavation and support) of Headrace Tunnel having excavated diameter ≥ 3 m and length ≥ 2000 m in a single Hydroelectric Project within the last Ten (10) years.
 - (ii) Participation as prime contractor or as a partner in joint venture and successful completion or substantial completion of construction of Powerhouse of a Hydroelectric Project having installed capacity ≥ 20 MW within the last Ten (10 Years)
 - (iii) Participation as prime contractor or as a partner in joint venture and successful completion or substantial completion of construction (excavation and support) of vertical/inclined Penstock Shaft having height/length ≥ 40 m in a single Hydroelectric Project within last Ten (10 Years)
- Able to demonstrate adequate Financial Resources, Manpower and Equipment to be used for the Project

- Under the Single Stage, Two Envelope Bidding procedure, bidders are required to submit the Technical Bid and Price Bid, as per the provisions of ITB 21 of the Bidding Document.
- Pre-bid meeting shall be held at Trishuli Jal Vidhyut Company Limited, Banasthali, Kathmandu on 7 Chaitra, 2080 (20 March, 2024) at 14:30 Hours. It is strongly advised for the Bidders or their representatives to attend the pre-bid meeting but it is not mandatory.
- Bidders are required to visit the Project Site and familiarize themselves with local conditions. The
 cost incurred for the preparation of the Bids and Site visit will be solely at the expense of the bidder.
 Failure to submit the Site Visit Certificate along with bid shall result in the rejection of the bid.

The bids will be opened in the presence of Bidders' representatives who choose to attend at 14:00 Hour on 20 Chaitra, 2080 (2 April, 2024) at the office of Trishuli Jal Vidhyut Company Limited, Banasthali, Kathmandu. Bids must be valid for a period of 120 days after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of NRs 56,000,000/- (In Words: Fifty-six Million Rupees Only) which shall be valid for 30 days beyond the validity period of the bid.
- 10. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid and bid security shall remain the same as specified for the original last date of bid submission.
