- Trishuli Jal Vidhyut Company Limited has allocated funds towards the cost of construction of Upper Trishuli 3B Hydroelectric Project in Nuwakot and Rasuwa Districts, Bagmati Province and intends to apply part of the funds to cover eligible payments under the Contract for **Lot 2 Electromechanical and Hydromechanical Works of Upper Trishuli 3B Hydroelectric Project (37 MW)**, Contract Identification No.: TJVCL/ICB/2024/EM-HM-01. Bidding is open to all eligible bidders as per Part V of the Bidding Document.
- Trishuli Jal Vidhyut Company Limited invites electronic bids from eligible bidders for the **Lot 2 Electromechanical and Hydromechanical Works of Upper Trishuli 3B Hydroelectric Project (37 MW) under International Competitive Bidding – Single Stage Two Envelope Bidding procedures**. Only eligible bidders with the following key qualifications should participate in this bidding:
 - Minimum Average Annual Construction Turnover of the best 3 years within the last 10 years: **USD 12 Million**
 - Bidding Capacity should be equal to or more than **USD 11 Million**
 - Minimum Work experience of similar size and nature: The Bidder must have successfully completed at least one (1) Electromechanical and/or Hydromechanical Works contract in Hydroelectric project with installed **capacity \geq 37 MW and with contract amount equivalent to USD 8 Million or more (Single contract) as a Prime Contractor within the last ten (10) years.**
 - For the above or other contracts executed during the period of last ten (10) years a minimum experience in the following key activities:
 - Participation as prime contractor and successful completion of design, manufacture, supply, installation, testing and commissioning of **Francis Turbines of nominal output per unit \geq 19MW and gross head \geq 90m** in at least one Hydroelectric project within last ten (10) years with satisfactory trouble free operation for more than two years as evidenced by respective user's certificate.
 - Participation as prime contractor and successful completion of successful design, manufacture, supply, installation, testing and commissioning of **Francis Turbines of nominal output per unit \geq 19MW** in at least one Hydroelectric project outside the country of the manufacturer within last ten (10) years with satisfactory trouble free operation for more than two years as evidenced by respective user's certificate.
 - Participation as prime contractor and successful completion of design, manufacture, supply, installation, testing and commissioning of **Synchronous Generators for nominal output per unit \geq 23 MVA**, in two Hydroelectric projects in which at least one Hydroelectric project outside the country of the manufacturer within last ten (10) years with satisfactory trouble free operations for more than two years as evidenced by respective user's certificate.
 - Participation as a prime contractor and successful completion of design, manufacture, supply, installation, testing and commissioning of **Step- up power transformers of secondary voltage \geq 132kV, 23 MVA (three phase)** capacity in two Hydroelectric projects out of which at least one Hydroelectric project outside the country of the manufacturer within last ten (10) years with satisfactory trouble free operations for more than two years as evidenced by respective user's certificate
 - Participation and successful completion as a prime contractor/partner in joint venture/subcontractor in design, manufacture, supply, installation, testing and commissioning of **underground steel penstock pipe of length \geq 150m long and diameter \geq 3.5m** in single Hydroelectric project within last ten (10) years with satisfactory trouble free operation for more than two years as evidenced by respective user's certificate
 - Able to demonstrate adequate Financial Resources and Manpower to be used for the Project.

- Bidders are required to visit the Project Site and familiarize themselves with local conditions. The cost incurred for the preparation of the Bids and Site visit will be solely at the expense of the bidder. Failure to submit the Site Visit Certificate along with bid shall result in the rejection of the bid.

Bids must be valid for a period of **120 days** after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of **USD 350,000/- (In Words: United States Dollar Three Hundred Fifty Thousand Only) or NRs. 47,000,000/- (In Words: Forty-seven Million Rupees Only)** which shall be valid for 30 days beyond the validity period of the bid.
